CARBON REDUCTION PLAN GUIDANCE

Notes for Completion

Where an In-Scope Organisation has determined that the measure applies to the procurement, suppliers wishing to bid for that contract are required at the selection stage to submit a Carbon Reduction Plan which details their organisational carbon footprint and confirms their commitment to achieving Net Zero by 2050.

Carbon Reduction Plans are to be completed by the bidding supplier¹ and must meet the reporting requirements set out in supporting guidance, and include the supplier's current carbon footprint and its commitment to reducing emissions to achieve Net Zero emissions by 2050.

The CRP should be specific to the bidding entity, or, provided certain criteria are met, may cover the bidding entity and its parent organisation. In order to ensure the CRP remains relevant, a Carbon Reduction Plan covering the bidding entity and its parent organisation is only permissible where the detailed requirements of the CRP are met in full, as set out in the Technical Standard² and Guidance³, and all of the following criteria are met:

- The bidding entity is wholly owned by the parent;
- The commitment to achieving net zero by 2050 for UK operations is set out in the CRP for the parent and is supported and adopted by the bidding entity, demonstrated by the inclusion in the CRP of a statement that this will apply to the bidding entity;
- The environmental measures set out are stated to be able to be applied by the bidding entity when performing the relevant contract; and
- The CRP is published on the bidding entity's website.

Bidding entities must take steps to ensure they have their own CRP as soon as reasonably practicable and should note that the ability to rely on a parent organisation's Carbon Reduction Plan may only be a temporary measure under this selection criterion.

The Carbon Reduction Plan should be updated regularly (at least annually) and published and clearly signposted on the supplier's UK website. It should be approved by a director (or equivalent senior leadership) within the supplier's organisation to demonstrate a clear commitment to emissions reduction at the highest level. Suppliers may wish to adopt the key objectives of the Carbon Reduction Plan within their strategic plans.

Sabio Ltd is committed to achieving Net Zero emissions by **2050**.

Baseline Emissions Footprint

Baseline emissions are a record of the greenhouse gases that have been produced in the past and were produced prior to the introduction of any strategies to reduce emissions. Baseline emissions are the reference point against which emissions reduction can be measured.

Baseline Year: 1st October 2021- 30th September 2022

Additional Details relating to the Baseline Emissions calculations.

Data collection and analysis has strictly followed the GHG Protocol Corporate Accounting and Reporting Standard. The World Resources Institute (WRI) and the World Business Council for Sustainable Development (WBCSD) developed the standard to promote standardised global carbon accounting methodologies and as such, the GHG Protocol Standard is one of the recommended methodologies under SECR guidelines. UK Governments 2022 emission factors, generated by DEFRA, have been used to quantify all emissions, with the exception of overseas electricity, which has been quantified using electricity emission factors calculated by the EIB, EEA or reported directly by the National Government. Sabio's data inputs have been reviewed and processed by Carbon Responsible Limited.

Current Emissions Reporting

Reporting Year: 1st October 2024 – 30th September 2025

In FY25, Sabio achieved a **37.0% reduction** in total greenhouse gas emissions (–553.32 tCO₂e year-on-year), reporting 943.32 tCO₂e across all scopes. Emissions were predominantly driven by **Scope 3** activities (87.8%), with Scope 2 accounting for 11.6% and Scope 1 0.7%, reflecting the organisation’s low level of direct emissions.

The largest contributors to the FY25 footprint were employee commuting and homeworking (43.1%) and business travel (25.9%). The overall reduction in emissions was primarily driven by significant decreases in **business travel** (–50.8%), due to reduced air travel and fewer hotel stays and employee commuting and homeworking (–47.5%), reflecting lower commuting distances and changes in workforce patterns.

These reductions were partially offset by an increase in emissions from purchased goods and services (+25.2%), primarily driven by improved supplier data availability and expanded reporting coverage.

At a scope level, Scope 1 emissions decreased by **43.6%**, largely due to the reclassification of vehicle emissions from owned to leased assets. Scope 2 emissions increased slightly by 4.6% (+4.82 tCO₂e), reflecting higher electricity consumption. Scope 3 emissions decreased by **40.1% overall**, with reductions in travel and commuting outweighing increases associated with improved supply chain data.

Overall, FY25 reflects **measurable emissions reductions** supported by operational changes and ongoing improvements in **data quality and reporting coverage**.


This Carbon Reduction Plan has been completed in accordance with PPN 06/21 and associated guidance and reporting standard for Carbon Reduction Plans.
